JULY 10, 2017**

5. Petitions, Recognitions and Communications
 - A. Proclamation for Mayor’s Monarch Challenge – presented by Councilmember Jones

Councilmember Jones said that the Majestic View Park and Nature Center is participating on behalf of the City of Arvada in the National Wildlife Foundation's Mayors' Monarch Pledge. This national initiative encourages municipalities to provide much needed habitat for the declining population of the Monarch Butterfly, an iconic insect that has decreased in population by over 90% in the last 20 years.

To begin this challenge, Mayor Marc Williams signed the pledge on November 30, 2016. Then, the staff at the Nature Center selected 11 actions to be accomplished throughout 2017. Completing eight of those actions will allow Arvada to be part of the Leadership Circle; however, three fulfilled actions within one year of signing the pledge will satisfy our commitment. These actions include public outreach, landscape maintenance practice changes, public events, milkweed plant giveaways, and/or creating monarch habitats at schools and city properties.

With the efforts guided by the National Wildlife Foundation, taken by Majestic View Nature Center, and supported by the City of Arvada, we can set an example for members of our community and other municipalities to endeavor to restore the population of a beloved butterfly.

We recognize these efforts in proclaiming that the City of Arvada has taken the Mayors' Monarch Pledge in the year 2017.

Charlotte Sandkuhler and Karen Miller from Majestic View Park and Nature Center were present to accept the proclamation.
