B. Recognition of Michael McDonnell, Arvada Parks Manager for the 2018 Colorado Parks and Recreation Association Fellow Award presented by Mayor Pro Tem Marriott

Mayor Pro Tem Marriott said that on September 13, 2018 Parks Manager Michael McDonnell received the highest honor that can be bestowed to any Colorado Parks and Recreation Association (CPRA) member; the Fellow Award! The award has been in existence since 1957 which is as long as CPRA has existed.

Fellow Award criteria require that the nominees must have worked a minimum of eight years full-time service in a leadership capacity, with a minimum of five years full-time service in Colorado.

The award is given to individuals that embody the following traits and skill sets:

- Leadership
- Strategic Thinking and Planning
- Partnership and Collaboration Building
- Innovation
- Service

Michael embodied all of these traits and especially excelled in the Service trait so it was very apparent that he was most deserving of this award.

While receiving an award like this is special, even more special is the fact that Michael's father, Gary McDonnell, won the Fellow Award in 1976. Gary was the Director of Lakewood Parks and Recreation at the time and had served as the CPRA President in 1974.
