



**SUMMARY OF MINUTES OF THE MEETING OF THE ARVADA CITY COUNCIL HELD  
MAY 3, 2021**

1. Call to Order - 6:00 p.m.

In accordance with physical distancing guidelines, this Arvada City Council meeting was held in the City Council Chambers and remotely using webinar technology. Mayor Williams, Mayor Pro Tem Miller, Councilmember Fifer, Councilmember Ford, Councilmember Marriott, Councilmember Jones and Councilmember Simpson were present in the council chambers. Members of the public were given notice with instructions on how to participate with public comment.

A. Proclamation Honoring Frontline Workers - Presented by Mayor Williams

C. Proclamation for Poppy Month - Presented by Councilmember Jones

Councilmember Jones said that this proclamation designates May as Poppy Month in Arvada.

The red Flanders poppy was first described as a flower of remembrance by a World War I colonel who wrote in pencil on a page torn from his dispatch book a verse describing how the poppies grew among "row on row" of graves of soldiers who had died on Flanders battlefields located in western Belgium and northern France.

In 1923, unemployed and disabled veterans began to produce artificial poppies. From this beginning the Flanders Field Poppy promotion was born, and since that time proceeds raised through the promotion of the Flanders Field Poppy have been used exclusively for the benefit of disabled and needy veterans and the widows, widowers and orphans of deceased veterans.

Following this meeting, the proclamation will be sent to American Legion Auxiliary Wilmore-Richter Unit 161.
