- This permit is strictly and only for the consumption of **BEER** and does not allow the selling of beer.
- A \$15 Processing Fee is assessed for the **Beer Permit**. **Please send a check for \$15 made payable to:**
 - **City of Arvada, 3rd Floor - R. Kougl, 8101 Ralston Rd, Arvada, CO 80001**
 - Your approved permit will be sent to you upon receipt of your \$15 check.
- The City also reserves the right to charge a \$100 damage and littering fee if the pavilion is found in damaged or littered condition at the conclusion of your event, \$100 will be charged on the credit card used to apply for the alcohol permit to remediate the damage or litter.

I understand that

- I must **remain on the premises with a copy of this signed permit** for review by any police officer during the time the permit is effective.
- The park and/or facility used by our group are to be left in a state of cleanliness and repair.
- Section 66-32 of Arvada’s City Code states that public parks and facilities shall be open until 11pm and that this permit is valid from **11am** to **9pm** on the day requested.

Conditions of Issuance

1. I am 21 years of age on or before the date I am requesting this permit.
2. I agree to remain on the premises at all times while beer is being consumed. I agree to be responsible for the actions of members of my group and for any damage they might cause at the park site or facility
3. There will be no loud noise or violent conduct that would infringe on the reasonable privacy of individuals in the park or the surrounding areas of the park.
4. I understand that beer must not be transported or consumed in glass containers.
5. If the park site is left with excessive trash or is damaged, I understand that the damage deposit of \$100 will be used to cover the cost of cleanup or to repair the damaged property and that I am responsible for any additional costs.
6. Pursuant to CRS31-15-401 (1)(E) I understand persons operating under this permit must obey all lawful orders of any duly sworn officer of the law regarding violations of law.
