## BEER PERMIT APPLICATION

Permit for **Consumption of Beer ONLY** at Allen House, McIlvoy, Mechelen and Oak Park Pavilions

- A nonrefundable \$15 Processing Fee is assessed for the **Beer Permit** and will be paid online during the pavilion rental checkout process using the [CivicRec](#) online reservation system
- Please email completed permit application to [pavilions@arvada.org](mailto:pavilions@arvada.org) **AFTER** reserving an **ALCOHOL ELIGIBLE PAVILION** **and** paying the assessed pavilion and beer permit fees [Application **MUST** be submitted a minimum of 10 days prior to the event]
- This permit is strictly and only for the **CONSUMPTION OF BEER** and does not allow the sale of beer
- Upon approval, your permit will be emailed to the account used for the pavilion reservation

**CONDITIONS OF ISSUANCE**

- I am 21 years of age on or before the date I am requesting this permit.
- I agree to remain on the premises at all times while beer is being consumed, with a copy of this signed permit for review by any police officer during the time the permit is effective.
- I agree to be responsible for the actions of members of my group and for any damage they might cause at the park site or facility.
- Pursuant to Section 66-32 of Arvada City Code, public parks and facilities shall be open until 11pm and this permit is valid from **11am** to **9pm** on the event date.
- Pursuant to Section 38-61 of Arvada City Code, there will be no excessive or unusually loud noise by occupants of the pavilion
- Pursuant to Section 62-50 of Arvada City Code, conduct of the occupants of the pavilion shall remain lawful and not offensive, and shall not create a breach of peace of other individuals in the park or the surrounding areas.
- I understand that beer must not be transported or consumed in glass containers.
- The City reserves the right to charge a \$100 fee to the credit card used for the pavilion rental and alcohol permit, should the park or pavilion be found in damaged or littered condition at the conclusion of the event. I am also responsible for any additional costs.
- Pursuant to CRS 31-15-401(1)(E), I understand persons operating under this permit must obey all lawful orders of any duly sworn officer of the law regarding violations of the law.

I have read and agree to the conditions stated in this permit and what is expected of me.
