Fees are in accordance with Section 102-34 of the Arvada City Code. Fees may be paid as early as the time an approved building permit is presented, but no later than the time the temporary certificate of occupancy or certificate of occupancy is issued.

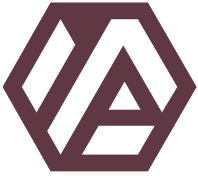

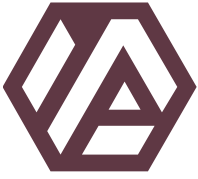
